B. Background

ASEAN Parliamentarians for Human Rights (APHR) is a not-for-profit membership organization made up current and former parliamentarians from Southeast Asia and beyond, who use their unique positions and innovative means to prevent discrimination, uphold political freedom, and promote democracy and human rights throughout the region.

APHR is a non-political, non-partisan membership organization and has no links or affiliations to any political parties and does not work directly with political parties. It supports the work of civil society and human rights defenders and encourages sustainable solutions that increase pressure on governments and multilateral bodies to ensure accountability and uphold and enforce international human rights laws and standards. APHR currently works on five thematic areas of work, namely: democracy and fundamental freedoms, freedom of religion or belief, business and human rights, climate change and human rights, and refugee rights and related rights concerns.

APHR was founded in June 2013 with the objective of promoting democracy and human rights in all ASEAN states. It represents a regional response to human rights concerns, utilizing the specific characteristics and abilities of parliamentarians to advocate for the protection of human rights throughout the region. APHR has an existing and active network of over 118 MPs from eight ASEAN nations (Cambodia, Indonesia, Malaysia, Myanmar, Philippines, Singapore, Thailand) including Timor Leste, and has demonstrated track-record in hosting high-level conferences and workshops, and coordinating a response when human rights violations occur.

APHR has been registered in Indonesia since 2015. APHR has a Secretariat of 11 full-time staff with 2 incoming staff in 2022 spread across the ASEAN capitals (KL,

Manila, Jakarta, and Bangkok). Currently, it has 11 Board Members from the 8 ASEAN countries (Cambodia, Malaysia, Myanmar, Indonesia, Philippines, Singapore, Thailand, and Timor Leste).
